Overall outcome

The school does not meet all of the independent school standards that were checked during this inspection

Main inspection findings

Part 3. Welfare, health and safety of pupils

Paragraphs 7, 7(a), 7(b), 11, 12, 16, 16(a), 16(b), 32(1), 32(1)(c)

- At the previous inspection, arrangements made to safeguard and promote the welfare of pupils were not sufficient. The school's safeguarding policy and practice did not have regard to the latest guidance issued by the Secretary of State. Staff had not received regular safeguarding training. Leaders' safeguarding records were not always accurate. Leaders did not always take timely or effective action to respond to concerns about pupils' welfare. Leaders had not ensured that they were following appropriate health and safety, fire-risk or risk assessment procedures to ensure that pupils were safe, and that their welfare was sufficiently promoted.
- Leaders have ensured that the safeguarding policy, which is available on the school's website, has regard to the latest guidance issued by the Secretary of State. All staff have read this latest safeguarding guidance.
- Staff have received appropriate safeguarding training in such areas as recognising the signs of abuse, county lines drug trafficking, the 'Prevent' duty and supporting children with additional vulnerabilities. Staff have also received appropriate safer handling training.
- Leaders have recently introduced a new system to record safeguarding concerns. However, staff have not yet received training on this system. It is too early to judge the effectiveness of this recently adopted system.
- The proprietor has ensured that an appropriate health and safety policy has been drawn up. However, the policy has not been approved by the trustees. It is too early to evaluate whether the policy is effective.
- Leaders have failed to resolve concerns regarding fire safety that were raised at the previous inspection. During this current inspection, some buildings were found to not have fire extinguishers in them. In other buildings, fire extinguishers were found locked in rooms and therefore not immediately accessible to some staff in the event of a fire.



This practice, which was identified at the last inspection, continues to place both pupils and staff at risk.

- The proprietor has ensured that a fire-risk assessment of the premises has been undertaken. However, it was not clear at the time of the inspection as to what action leaders had taken to resolve the identified risks, one of which was classified as 'high'.
- The proprietor has ensured that an appropriate risk assessment policy is now in place. Leaders have made sure that pupils' individual risk assessments are detailed and are available to staff. However, staff have yet to receive training on how to complete accurate risk assessments for pupils in their own learning groups, to safeguard pupils' welfare.
- The school does not meet the requirements of all the independent school standards in this part.

Part 4. Suitability of staff, supply staff, and proprietors

Paragraphs 20(6), 20(6)(a), 20(6)(a)(i), 20(6)(b), 20(6)(b)(i), 21(6)

- At the previous inspection, leaders had not made the necessary checks on staff's suitability to work with children. Due to a lack of training, over time, leaders did not know which checks to make. Appropriate checks had also not been made on the proprietor.
- The proprietor has ensured that leaders have received appropriate safer recruitment training. All the necessary checks are now made on adults before they commence their employment. The single central record meets statutory requirements. Leaders have ensured that the necessary checks on the proprietor have been undertaken.
- The school meets the requirements of all the independent school standards in this part.

Part 5. Premises of and accommodation at schools

Paragraphs 23(1), 23(1)(a), 24(1), 24(1)(b), 25, 28(1), 28(1)(b)

- At the previous inspection, inspectors found that the toilet and washing facilities were not suitable. There was no washing facility present in the accommodation provided for the short-term care of sick and injured pupils. The premises and accommodation were not maintained to a standard, such as is reasonably practical, to ensure the health, safety and welfare of pupils.
- The proprietor has ensured that a washing facility is now present in the accommodation provided for the short-term care of sick and injured pupils. The toilet and washing facilities are now suitable. The premises are maintained to an appropriate standard.
- The school meets the requirements of all the independent school standards in this part.

Part 6. Provision of information

Paragraphs 32(1), 32(1)(b), 32(1)(h)

- At the previous inspection, leaders had not ensured that all the required policies were available. The proprietor has ensured that all policies are now available.
- At the previous inspection, the proprietor had not ensured that leaders provided local authorities with reports detailing how the school uses the money received for pupils whose places at the school were funded by the local authority. This remains the case.
- The school does not meet the requirements of all the independent school standards in this part.

Part 8. Quality of leadership in and management of schools

Paragraphs 34(1), 34(1)(a), 34(1)(b), 34(1)(c)

- At the previous inspection, the proprietor had not ensured that pupils' welfare, health and safety were fully considered. The necessary checks had not been undertaken on some staff to ensure that they were suitable to work with children. The safeguarding arrangements were not effective. Not all relevant policies and documents were made available.
- The proprietor has not ensured that the leaders have a secure understanding of the independent school standards. There has not been sufficient action to ensure that the school now meets all the standards that the previous inspection judged as not met. Many of these standards remain unmet. This includes standards that relate to the welfare, health and safety of pupils.
- The proprietor has employed an external consultant to review the progress leaders are making to ensure that the independent school standards are met. The review shows that while leaders are acting to address the failings, these actions have not yet been completed to the extent that the standards previously judged as not being met are now met.
- The school does not meet the requirements of all the independent school standards in this part.

The school does not meet the requirements of the schedule to The Education (Independent School Standards) Regulations 2014 ('the independent school standards') and associated requirements that were checked during this inspection, as set out in the annex of this report. This included the standards and requirements that the school was judged to not comply with at the previous inspection. Not all of the standards and associated requirements were checked during this inspection.

Information about this school

- Hope House School is an independent special school. The school is situated in Newark, Nottinghamshire.
- The school ceased use of the residential provision in February 2020.



- The school admits pupils aged five to 19 who have a diagnosis of autism spectrum disorder. Many pupils have a range of behavioural, social, emotional and mental health difficulties.
- All pupils have an education, health and care plan.
- The members of the proprietorial body, the trustees, took up their roles in February 2020. The chair of the board took up their role in November 2020.
- The school no longer owns a residence that it uses for pupils and students to learn independent living skills.
- The school does not make use of any alternative provision.
- The school's previous inspection took place on 28 to 30 January 2020 and found the school to be inadequate.
- The principal and vice-principal were not present during the inspection.



Information about this inspection

- This inspection was carried out at the request of the registration authority for independent schools. The purpose of the inspection was to monitor the progress the school has made in meeting the independent school standards and other requirements that it was judged to not comply with at its previous inspection.
- Unmet standards from the previous inspection regarding the school's residential provision were not checked as the school no longer uses this facility.
- The school submitted an action plan indicating how leaders would tackle the unmet standards. This plan was accepted by Ofsted in November 2020.
- I held various meetings with leaders, including the pupil manager, education manager and human resources manager. I held further meetings with the chair of the board, the site manager, five members of staff and held a telephone conversation with the school's educational consultant.
- I met with leaders to discuss safeguarding. I checked staff training records, the single central record and the system for the recruitment and appointment of new staff. I toured the school site to check compliance against Part 5 of the independent school standards.
